It aggregates orders for all government agencies, achieving economies of scale when sourcing from manufacturers and distributors. Under Republic Act 9502's Cheaper Medicines Law, PPPI establishes a common facility for pooled procurement of medicines. This is in line with the Universal HealthCare Act of 2019, Philippine Medicines Policy for 2022 to 2030, and the Integrated Roadmap of the Philippine Pharmaceutical Industry. PPPI offers commonly ordered medicines for primary health care to local government units and other government entities.

Ordering Instruction: For tablet and capsule form, orders should be in commercial packs

INSTRUCTIONS

- Processing of Purchase Orders (POs)** - PPPI does not maintain a stockpile of the above medicines. It will get the medicines from the winning suppliers once there are orders from government entities. To have economies of scale, consolidation of orders will be every two (2) weeks. Orders received after a certain cut-off will be processed during the next cut-off. The schedule of the cut-offs for the consolidation of POs for the 1st half of 2024 are as follows:

21 March 2024, Thursday
04 April 2024, Thursday
18 April 2024, Thursday

02 May 2024, Thursday
16 May 2024, Thursday
30 May 2024, Thursday

13 June 2024, Thursday
27 June 2024, Thursday

- To ensure that the quality of the medicine is not compromised, orders for medicines in tablet and capsule form must be in commercial packing size
- Documentary requirements needed:**
 - Duly signed Purchase Order (PO)
 - Obligation Request (ObR) or Certificate of Availability of Funds (CAF)
- Delivery Period**
 - National Capital Region - 21 calendar days from cut-off date
 - Luzon - 25 calendar days from cut-off date
 - Visayas, Mindanao and Out-of Delivery Areas - 33 calendar days from cut-off date
- Payment Terms**
 - 15 calendars days from receipt of medicines
 - Payment via Advice to Debit Account (ADA) to PPPI's Land Bank of the Philippine (LBP) Account; Official Receipt will be mailed to the government entity
 - If ADA facility is not available, check payment issued to Philippine Pharma Procurement, Inc.; check to be deposited by client at PPPI's LBP account
 - For the purpose of issuing BIR Form 2307, PPPI's TIN No. is **000-598-366-00000**

PPPI makes available to LGUs or GAs the latest Price List via mail or thru the PPPI website

2

ORDER GENERATION

LGU or GA procures from PPPI using the Agency-to-Agency procurement modality under Sec 53.5 of the IRR of RA 9184. LGU or GA then submits the duly signed PO to PPPI together with the Obligation Request (ObR) or Certificate of Availability of Funds (CAF).

PROCESSING AND DELIVERY OF ORDERS

PPPI processes the PO based on the scheduled cut-off dates and delivers the medicines to the LGU or GA within 21 days from cut-off date for NCR, 25 days for Luzon and 33 days for Visayas, Mindanao and ODA areas.

4

RECEIPT OF GOODS BY CLIENT

PPPI contracted forwarder delivers the medicines to the LGU or GA together with the original copy of the Sales Invoice (SI), photocopy of the Certificate of Product Registration (CPR) and Certificate of Current Good Manufacturing (cGMP). (COA Circular 2023-004)

PAYMENT TO PPPI

Authorized LGU or GA personnel receives the medicines and processes payment to PPPI within 15 calendar days from receipt of medicines.

LGU or GA credits the payment to PPPI's Land Bank of the Philippines (LBP) account via Advice to Debit Account (ADA) or check deposit

6

ISSUANCE OF OFFICIAL RECEIPT

PPPI issues the Official Receipt (OR) and mails the original copy to the LGU or GA.

Upon receipt of OR, the LGU or GA sends via mail to PPPI the original copy of BIR Form 2307.

RELEVANT LAWS AND ISSUANCES ON THE PROCUREMENT OF MEDICINES

DOH AO NO. 2012-0023 ITEM VII.B.2

Only medicines that are reflected in the Philippine National Formulary(PNF) manual can be requisitioned in the procurement of medicines by all government agencies, i.e., national government agency and the health facilities under their supervision and control of the DOH, devolved health facilities under the Local Government Unit and Government Owned and Controlled Corporation.

RA9184 OTHERWISE KNOWN AS THE GOVERNMENT PROCUREMENT REFORM ACT ARTICLE VI SEC 18

Section 18 . Reference to Brand Names - Specifications for the Procurement of Goods shall be based on relevant characteristics and/or performance requirements. Reference to brand names shall not be allowed.

RA6675 OTHERWISE KNOWN AS THE GENERIC LAW OF 1988 SEC 6

Section 6. Who Shall Use Generic Terminology - All government health agency and their personnel as well as other government agency shall use generic terminology or generic names in all transactions related to purchasing, prescribing, dispensing and administering of drugs and medicines.
